



ADOM (Alcohol and drug measure) is mandated by the Ministry of Health to be offered to tangata whai ora in community addiction services in Te Whatu Ora District's and NGO's. Below is an indication of how well the information is being collected. While there is currently no target for ADOM collections, there is clearly room for improvement.

² Teams within NGOs are assigned to a Te Whatu Ora district area.

³ Some teams in the list are excluded. This is because the team is coded as a community mental health team, and AOD only referrals cannot be differentiated.
