



ADOM (Alcohol and drug measure) is mandated by the Ministry of Health to be offered to tangata whai ora in community addiction services in Health New Zealand | Te Whatu Ora District's and NGO's. Below is an indication of how well the information is being collected. While there is currently no target for ADOM collections, there is clearly room for improvement.

¹ There are no or small numbers of eligible NGOs currently in Nelson Marlborough district area. It is not possible at this point to disaggregate AoD tāngata whai ora in integrated mental health teams for Hutt Valley District. Wairarapa District the services are delivered by NGOs.

² Teams within NGOs are assigned to a Health New Zealand district area.

³ Some teams in the list are excluded. This is because the team is coded as a community mental health team, and AOD only referrals cannot be differentiated.
